The fiat value of PryvateCoin is highly volatile and it could lose all value. We do not control and we are not responsible for the value of our utility tokens.

With accepting Terms and Conditions you agree and acknowledge that any purchase of PVC utility token by you or on your behalf is made voluntarily and exclusively at your own risk.

You agree and acknowledge that you are solely responsible for the secure storage of any PryvateCoin and you agree that in no event will pryvatecoin.io be liable for the security or control of any user's utility tokens.
